

## **Hanover ConnectEast Ride for Home Individual and Team Fundraiser Prizes**

### **Terms and Conditions**

1. All teams, networks and individuals who fundraise are automatically eligible for these prizes. Entry into the *Ride for Home* is deemed acceptance of these terms and conditions.
2. Entry is open to all residents of Australia only.
3. The competition commences on **22<sup>nd</sup> July, 2011 at 2.00 am** (AEST) and concludes on **12<sup>th</sup> December, 2011 at 9.00 am** (AESDT).
4. To enter, participants must be a **Hanover ConnectEast Ride for Home** participant with an individual or team online fundraising page on **Hanover ConnectEast Ride for Home** 2011 website ([www.rideforhome.com.au](http://www.rideforhome.com.au)).
  - An individual that is part of a team in the **Hanover ConnectEast Ride for Home** is also eligible to enter the individual fundraising prize on the condition that the individual has their own separate individual fundraising page.
